Dear Parents,

One of our Meadow Point goals is providing a safe environment where teachers can teach and students can learn. In order for students to reach their academic potential, it is important for students to feel safe in the school environment. The aspects of school safety include students feeling safe on their way to and from school. Please remember to not leave cars unattended in the drop off/pick up lanes so we can keep cars moving and please keep children off of the playground before and after school, especially after school until 3:30. This will help us make sure that all students are accounted for and those students that are not picked up will be brought to the office to call home. It takes an effort from everyone to help make Meadow Point a safe and inviting place for students. Thank you for your help! Below is some information about our school and district efforts to make sure Cherry Creek Schools are safe and prepared to handle emergency situations.

#### **Emergency Response and Crisis Management in the Cherry Creek Schools**

As a result of funds received from an Emergency Response and Crisis Management (ERCM) grant from the Office of Safe and Drug Free Schools, all leadership and school safety/crisis teams in the Cherry Creek Schools have been receiving ERCM training and have developed updated and effective emergency response plans and procedures that align with state and federal Homeland Security Emergency Management and the National Incident Management System. We have improved communications with our community agencies, trained key staff to provide for the emotional impact of a crisis on students and staff, and developed sustainable training materials and crisis response kits for our schools.

We would also like to take this opportunity to inform parents about recent changes to the Cherry Creek Website that now give parents needed information about school safety and related issues. The website explains the district's efforts to provide for both the physical and psychological safety of our children, and gives parents links to excellent on-line resources. # Attention Parents: Airsoft, Pellet, BB Guns Are Not Toys at School

At this time we want to reiterate our message regarding state law and school district policy relative to airsoft, pellet, and BB guns. We understand that these guns, which can be difficult to distinguish from real guns when being held by a person, have become very popular. We further understand that many view these guns to be toys. As such, some of our students are purchasing these guns, receiving them as gifts, and playing with them at home and in neighborhoods with parental permission. However, **these guns are not allowed on school premises.** Both Colorado state law and Cherry Creek School District policy require a **mandatory expulsion** for the possession on school property of "any pellet or BB gun or other device designed to propel projectiles by spring action or compressed air."

Please be reminded and reinforce with your child that the school must recommend an expulsion if these guns are brought onto school premises.

#### **EARLY ARRIVAL**

Children should not arrive before **8:10 a.m.** if they are coming for breakfast otherwise not until **8:30 a.m.** The first bell is 8:35 a.m. and all students should be lined up at that time. If a child arrives before 8:10 a.m. the office will be making a call home to inform the parent/guardian that their child has arrived too early for school. Please be aware that we have no supervision on the playground until 8:30 a.m.

#### **School of Choice**

School of Choice applications for the 2011-12 school year will be available starting at 7:30am on November 15, 2010 in all schools and the District Admissions offices. Forms must be fully completed before being submitted, and will then be date & time stamped by district staff as received. All transportation arrangements become the responsibility of the family choosing this option.

Requests are approved based on available space with priority given to siblings of current students already attending that school and the children of district staff according to negotiated employee policies. Notification of acceptance or denial of the request will be sent from the schools to parents by March 15, 2011.

If your student is currently attending a School of Choice or IntraDistrict Transfer to the highest grade level, it is NOT necessary to complete a School of Choice application each year. Non-Resident application will be available starting April 1, 2011.


